We wanted to express our most sincere gratitude for the highly professional and comprehensive services you have and continue to provide us at CompassCare Pregnancy Services. In November of 2001 converting to a medical model CPC was simply a dream of a small and fearful CPC in troubled New York State. We knew that we were supposed to move in a medical direction, but we were without funds and without the requisite expertise. After linking arms with NIFLA, we were 'fast-tracked' into the reality of our vision. Taking many large steps of faith and watching the Lord provide we were one of the first in New York to be actively providing medical services 40 hours per week, nine (9) months later on July 29, 2002! The Board training, the Policy and Procedure helps, the wonderful technical consultation, marketing ideas, and more met our needs on virtually every level. Without the help and resources of NIFLA, it would have taken us three or four years to effectively convert to the medical model.

Since our conversion and the addition of ultrasound technology, we have seen an increase in clientele by over 50% and the number of abortion-vulnerable clientele choosing life has gone from 60% to over 95%!

We could never hope to thank you enough for all that you have done for us and all that you have done for pro-life CPC's. We look forward with great anticipation to a wonderful and continued relationship as we work toward erasing the need for abortion together.


